I. GENERAL INFORMATION

This final report provides information on the results of revenues, expenditures, and monitoring of financial activities of electoral subjects participating in the October 2, 2021 municipal elections of Georgia, during the election period.

A total of 43 parties¹ and 68 independent candidates participated in the elections.

In accordance with the Election Code of Georgia and the Order of the Auditor General of Georgia², the electroral subjects were requested to submit a report on the election campaing finances according to the followinng periods:

- Information from 2021 August 2 to August 22 until August 26;
- Information from 2021 August 23 to September 12 until September 16;
- Information from 2021 September 13 to October 2 until October 7;
- Information from 2021 August 2 to October 2 until October 14 (by those electoral subjects who had received the required number of votes as defined by the Election Code of Georgia based on preliminary data);
- Information from 2021 August 2 to the announcement of the final election results a month after publication of the results (all electoral subjects participating in the elections);
- Financial report of the activities carried out after the voting day of the first round (October 2) 3 days before the day of the second round (all electoral subjects participating in the second round);
- Information from 2021 August 2 to the announcement of the final results of the election a month after publication of the results of the second round (all electoral subjects participating in the second round).

State Audit Office (SAO) has renewed the Regulation on Transparency of Political Finances, including: information on loan/credit and gender-based financing has been added to the reporting forms, the definition of an election campaign fund has been improved, electronic document management rules and other regulations has been included. The updated information has been published on the website of the institution and sent to all electoral subjects.

On August 17, 2021, meetings have been hosted with the representatives of electoral subjects to discuss their reporting obligations during the election period and legislative innovations. The meeting was attended by representatives of 26 parties.

On September 17, 2021, at the invitation of the SAO, together with the local and international nongovernmental organizations working on elections, over an information/advisory meeting the issues of submission and analysis of election campaign financial reports, study of received applications and donations, and other issues have been discussed.

II. ELECTION CAMPAIGN FINANCES

1. REVENUES

Electoral subjects have two main sources of revenue: donations and budget funding.

All electoral subjects received 28,056,925 GEL revenues in the period from August 2 to November 3³, namely:

In order to verify the revenues and expenditures declared by the electoral subjects, the SAO systematically compares them with the bank statements of the subjects and the results of the media monitoring.

III. MONITORING RESULTS

1. STUDY OF DONATIONS, ELECTION CAMPAIGN FUND REPORTS, RECEIVED COMPLAINTS AND MEDIA MONITORING RESILITS

The SAO has requested financial reports for the monitoring purposes: from the parties covering the period from June to July 2021, and from electoral subjects - from August 2, 2021 to November 13, 2021.

In order to study the legality of the donations, the respective information was requested during the examining financial statements: from the Revenue Service on income and tax liabilities of – 1,149 individuals and 63 legal entities; From commercial banks – information on transactions made over the bank accounts of 61 individuals. Also, 10 persons have been interviewed for additional explanations, in order to substantiate their income.

As a result of the study of the financial statements, six facts of making donations in the bank account of parties (in cash) 10 with violation of the requirements of the Organic Law of Georgia on Political Union of Citizens have been revealed. The SAO responded to the above-mentioned cases accordingly, electoral subjects were asked to refund the money. Into this six violation were eliminated.

In the scope of monitoring the financing of the election campaign, as a result of the complaints submitted to the SAO during the election period, data following the media monitoring carried out by the institution and information provided by the electoral subjects, administrative proceedings have been initiated in 31 cases, including:

- In 29 cases, an administrative offence protocol has been drawn up on 29 cases and submitted to the court for confirmation.
- Two administrative offence case proceedings was terminated in the absense of breaching the law.



2. CASES OF ADMINISTRATIVE OFFENCES

In the period from August 2 to August 16, 2021, 87 (ninety-seven) individuals and 5 (five) legal entities from Samtskhe-Javakheti donated a total of 714,000 GEL to the "Georgian Dream-Democratic Georgia" party.

In this regard, the SAO based on the court order, requested information from the Revenue Service the income of the donors. SAO also additionally requested information on transactions made with 12 donors in the accounts opened in commercial banks registered in Georgia. One person has been interviewed for additional explanations.

Based on the study of the case, the fact of implementation of donations with violation of the requirements established by the law was not revealed.

In September 2021, outdoor advertising banners were placed across the country with political content for restraining support of several political forces, with the inscription: "No to Nazis, no to evil, no to betrayal."

SAO started proceedings regarding above-mentioned case, to determine the legality of the expenses for the placement of the banners. For this purpose the SAO requested following information from the companies¹¹ owning banner placements about placement and expenses of the baners¹²; information from the Revenue Service, as well as comercial banks, and the income and financial condition of the donors. Additional information was also obtained from the donor.

As a result of the study, the fact of implementation of the violation in accordance with the requirements established by the legislation was not revealed.

- The SAO conducted administrative proceedings on 4 cases of violations of the legislation governing political finances by the party New Political Center - "Girchi":
 - In connection with the elections of October 2, 2021, the party "Girchi", sold the vacancies of its representatives in the district and regional election commissions through a public electronic auction, in several stages. The amount received as a result of the auctions - a total of 234,459.9 GEL was transferred to the bank account of the religious organization LEPL -Christian, Evangelical, Protestant, Church - "Biblical Freedom". With this, the party received revenue in violation of the requirements¹³ established by the Organic Law of Georgia on Political Unions of Citizens.
 - In the period from July 17 to October 20, 2021 party "Girchi" received a prohibited donation amount of - 9,634 GEL in the bank account of religious organization LEPL - Christian, Evangelical, Protestant, Church - "Biblical Freedom" in violation of the requirements14 established by the Organic Law of Georgia on Political Unions of Citizens.
 - In September 6 7, 2021, the party "Girchi" fictitiously transferred 324,174 GEL to I/E Otar Zakalashvili for web development services, after which it cashed this money and converted it

- into US dollars. On September 8, a Porsche Taycan was purchased for \$ 100,000 in cash for a further raffle. With the above-mentioned, the party "Girch" violated the established rule of non-cash payment¹⁵.
- The cost of purchasing a Porsche Tycan was not declared by the party "Girchi" and incorrect financial report was submitted to the SAO. The party "Girchi" violated the established rule by the law on accountability¹⁶.

According to the decision of the Tbilisi City Court of November 17, 2021, the party "Girchi" was found guilty of all the above-mentioned facts and was punished for the violation where the highest sanction is impose, the party was fined with double amount of the prohibited donation (19,268 GEL) and at the same time was forced to transfer prohibited donation (9,634 GEL) to the state budget.

- The State Audit Office conducted administrative proceedings on 3 cases of violation of the legislation governing political finances by the party "Girchi - More Freedom":
 - In the period from August 2 to October 16, 2021, party "Girchi More Freedom" has received prohibited donation in the amound of 47,590.77 GEL through 595 transactions on the bank account. Part of above-mentioned donation has been received in the foreign corrency in cash, as weel as through the webportal (www.girchi.org), from which the donor can not be identified, and in some cases the donation is not made from the donor's account. This is a statutory violation of the Organic Law of Georgia on Political Union of Citizens¹⁷. Following the case, an administrative offence protocol drawn up by the SAO was sent to the Tbilisi City Court. The court considered the case, identified the offence, fined the party "Girchi - More Freedom" with double amount of prohibited donation - 95,181.54 GEL and ordered to transfer of 47,590.77 GEL to the budget.
 - The Party "Grichi More Freedom" did not fulfilled its legal obligation to submit information about donations and membership fees (total ,15,031 GEL) to the SAO. An administrative offence protocol drawn up by the SAO was sent to the Tbilisi City Court. As a resut the party "Girchi – More Freedom" was fined with amount –5,000 GEL.
 - The Party "Grichi More Freedom" did not fulfilled its legal obligation to submit information about the financial reports of the first, second, third three-week periods, preliminary and second rounds of the election campaign to the SAO. An administrative offence protocol drawn up by the SAO was sent to the Tbilisi City Court. As a resut the party "Girchi – More Freedom" was fined with amount –5,000 GEL.

In addition to the above, 22 cases, including 18 independent candidates and 4 parties, were considered by the Tbilisi City Court on the basis of administrative violation reports drawn up by the State Audit Office regarding the violations revealed as a result of the examination of financial reports submitted by electoral subjects. The court issued a warning for all of them (see: Annex).
